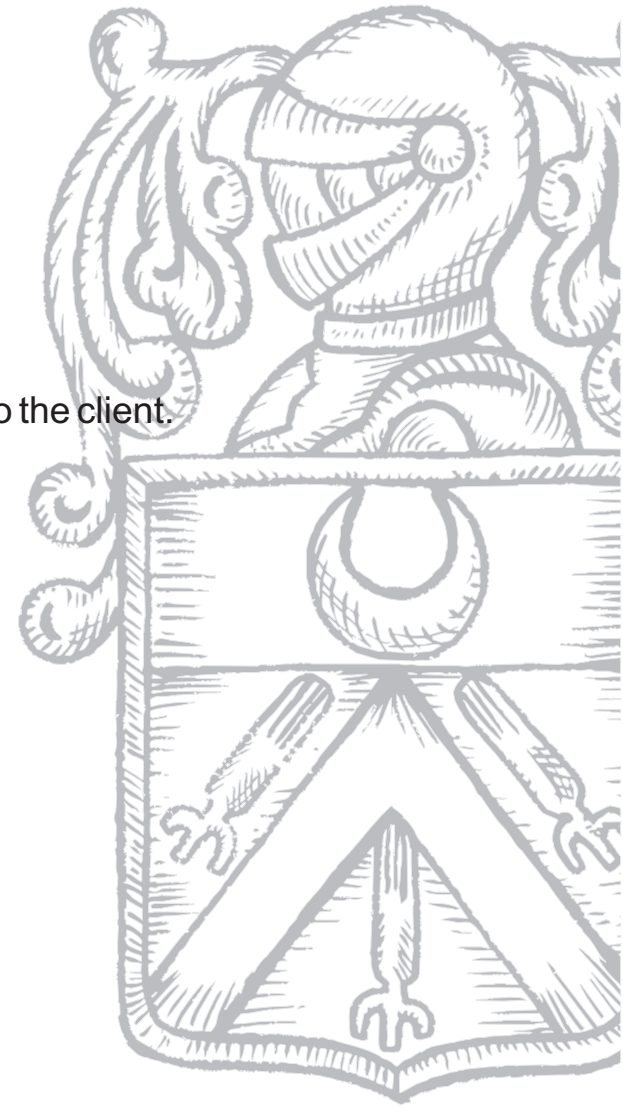


- ❖ We manage debt recovery without cost to the client until the debts have been recovered

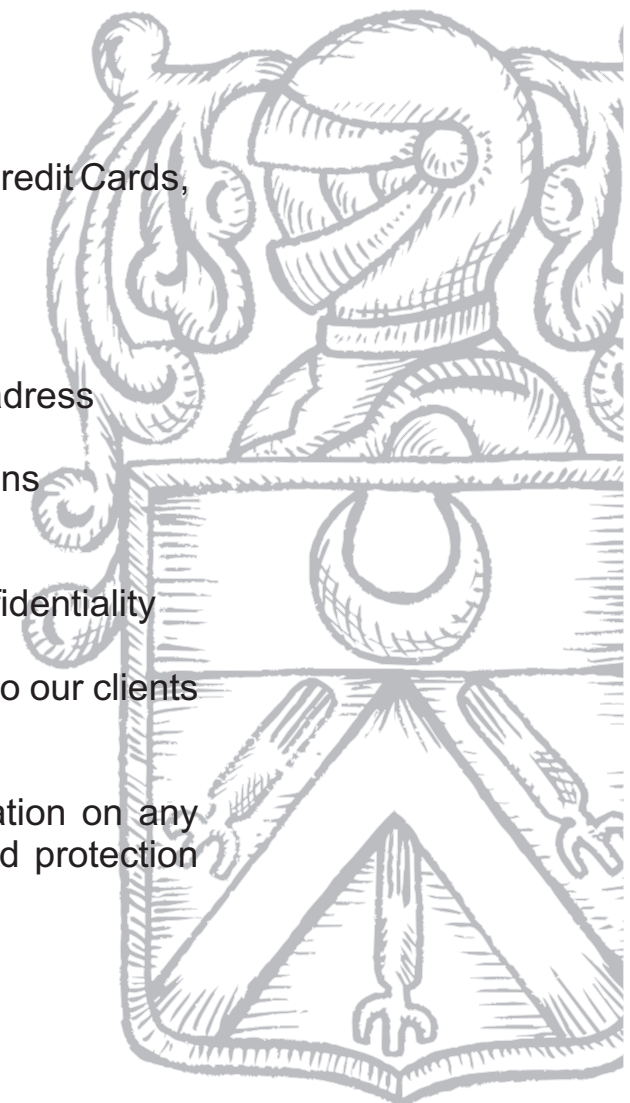

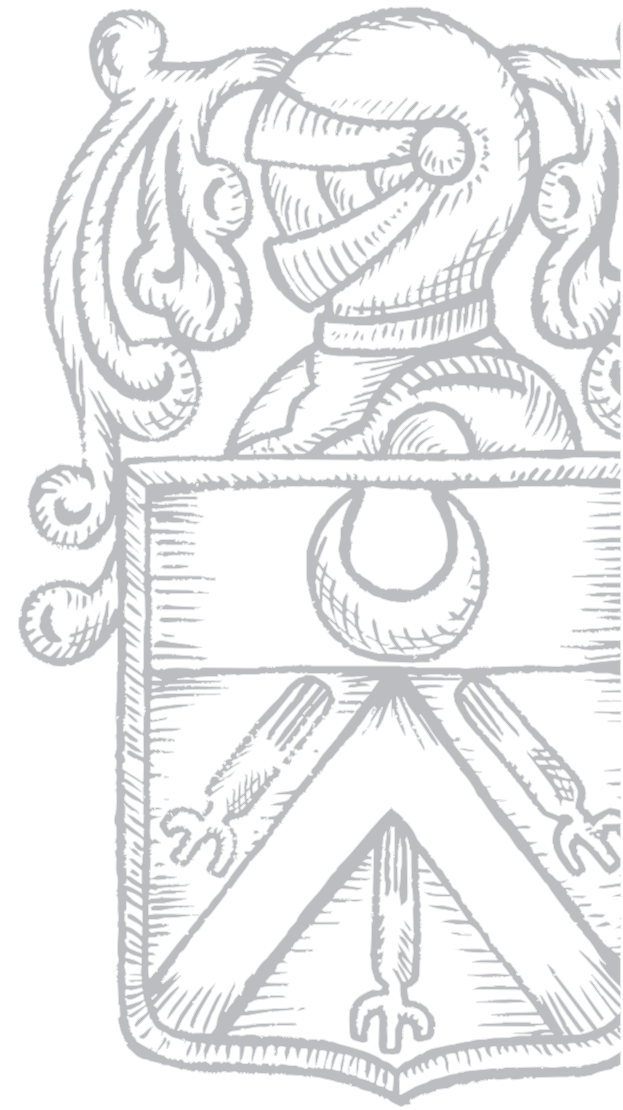
